

CONTRACT FOR SERVICES

This Agreement is made on 14 October 2020 between Nanyang Law LLC ("Corporation"), with its office at 11 Biopolis Way, #03-01/02 Helios Singapore 138667 and Peh Poh Heng (Jovi) (S7123457F)

This Agreement is subject to the following terms and conditions.

1. Independent Contractor

Your status under the Contract for Services shall be that of an independent contractor providing services as specified in Clause 2 herein, to the Corporation. Nothing herein contained shall constitute or be construed as constituting or have the effect of creating the relationship of employer and employee between the parties to this Contract for Services.

2. Services

The Corporation hereby appoints the Support to generally assist the Corporation in handling day to day secretarial and administrative functions, including but not limited to updating information via database and administrative documents filing, supporting senior management in secretarial matters, and such other related services as and when assigned in relation to intellectual property related matters ("Services").

3. Term of Agreement

The term ("Term") of this Agreement, hence the Services, shall be commence from 16 October 2020 and shall expire on 15 October 2021.

In the event that either party herein wishes to terminate this Agreement at any time, the party wishing to terminate shall give the other party notice of its intention to terminate ("Termination Notice") at least one (1) week prior to the date such termination is expected to take place.

4. Remuneration

In consideration for the Support rendering the Services, the Corporation agrees to pay the Support during the Term a rate of S\$10 per hour (all-in) on five days, per week basis. The working days shall be mutually agreed between the parties, Monday to Friday, 12.00pm to 3.00pm.

5. Confidentiality

The Support agrees at all times during the term of the Agreement and thereafter, to hold in strictest confidence, and not to use, except for the benefit of the Corporation, or to disclose to any person, firm or corporation without written authorization of the Corporation, any Confidential Information of the Corporation.

"Confidential Information" means any Corporation proprietary information, trade secrets or know-how, including, but not limited to, customer lists and customers, markets or other business information disclosed to the Support by the Corporation.

The Support further agrees that Confidential Information does not include any of the foregoing items which have become publicly known and made generally available through no wrongful act of her or others who were under confidentiality obligations as to the item or items involved.

6. Survival of Obligations

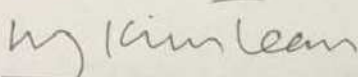
The Support agrees that this above Clause 5 undertaking shall survive the termination of his Services with the Corporation for any reason, whether with or without cause.

7. Applicable Law This Agreement is governed by the laws of the Republic of Singapore.

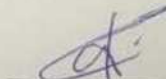

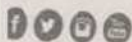
