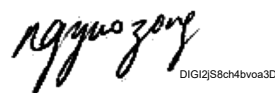

TERMS OF MEMBERSHIP

1. Designated Space and Common Equipment and Facilities

- 1.1 You will be provided with access to Designated Space for your use for the purpose of incubating your technology start-up company, or for technology development, or commercialisation of technology projects. You understand that the Designated Space is for your use only, and whilst you may have guests and/or visitors to your Designated Space, for the purposes of complying with fire and safety regulations, ***you shall not at any time host more than 5 guests and/or visitors without our prior consent. This includes activities held during or after A*StartCentral opening hours.*** The space shall not be used for purpose beyond that of incubation.
- 1.2 You shall not carry out any alteration, addition, improvement, erection, installation, or interference at the Designated Space without A*STAR Research Entities' ("ARES") prior written consent.
- 1.3 You are responsible for keeping the Designated Space clean, tidy, and in good repair.
- 1.4 You will be provided with access to common utilities, facilities and equipment, as well as common laboratory services accessible to all members of A*StartCentral. Certain facilities and/or equipment may be booked for specific periods of time. Basic cleaning services will be provided for common areas within A*StartCentral.
- 1.5 You understand that you are an invitee of ARES, and no lease or licence is conferred hereunder. No exclusive possession is provided for the Designated Space, and possession is at all times retained by ARES.
- 1.6 You accept the Designated Space on an "as is" basis and in its existing state and condition and shall be deemed to have full knowledge of any specifications and/or limitations thereof. ARES makes no representations, conditions or warranties, express or implied, with respect to the Designated Space, furniture, fittings and common equipment and facilities provided. Without limiting the generality of the foregoing, ARES expressly disclaims any implied warranty, condition or representation that the Designated Space, furniture, fittings and/or the common equipment and facilities are fit for your purposes.
- 1.7 In utilising the common equipment and facilities at A*StartCentral, you agree that:
 - (i) Your right to use any of the common equipment and facilities shall be subject to availability, and terms and conditions, and time allocated for the use;
 - (ii) You shall use the common equipment and facilities in a skillful and proper manner; and
 - (iii) You shall comply with all applicable rules and regulations when using the equipment and common facilities, including all safety regulations, requirements, precautions and procedures as may be issued and implemented by ARES from time to time (and notified to you).

2. Professional and Talent Development Services

- 2.1 A*StartCentral aims to provide a platform for its members to gain access to professional service providers and talent development services. You understand that your use of these services is subject to availability, and the advice given and/or services provided at A*StartCentral through this platform are rendered by volunteer professionals who may impose their own terms of service. You understand that you may be required to agree to these additional terms should you wish to engage their services.
- 2.2 Provision of access to these services does not imply an endorsement or a warranty of any of these services or the service providers by ARES, and ARES will not in any way be responsible or liable for any loss or damage incurred by you in your use of any these services, including but not limited to the disclosure of your confidential information to the professional service providers, talent development services or any other third party.

3. Members' Responsibilities

- 3.1 A*StartCentral is a community space. As such, you understand that you are entirely responsible for ensuring the confidentiality and security of your Designated Space, and your belongings stored there.
- 3.2 You are likewise responsible for the safety, and the acts and omissions of all your guests and other invitees to A*StartCentral. Photos of you and your guests could be taken, and be used for general publicity and social media.
- 3.3 Where relevant, you are responsible for applying for all necessary insurance coverage, relevant approvals, clearances and licences from the relevant governmental or statutory authorities e.g. the relevant licence for the use of poison and chemicals, and shall not commence its operations in the Designated Space unless and until all such approvals, licences and clearances have been obtained.
- 3.4 You agree not to use the Designated Space or the common areas and common equipment in such a way as to cause any nuisance, damage, disturbance, annoyance or interference to other members of A*StartCentral.
- 3.5 You are responsible for any and all damage you (or your invitees) cause to the common equipment and/or premises at A*StartCentral, and agree to fully indemnify ARES and its affiliates for any costs and expense arising out of such damage.
- 3.6 You agree that your use of the Designated Space shall comply with all relevant laws, regulations, guidelines, and requirements of the relevant authorities as well as the house rules as shall be communicated to you.

4. Membership Fees, Term and Termination

- 4.1 Membership is valid for a period of 12 months subject to prompt payment of the Membership Fees.
- 4.2 Membership Fees may be adjusted by ARES at any time upon written notice. Membership Fees paid are non-refundable. Membership Fees are payable on the first business day of each month via GIRO, or automated monthly electronic fund transfer to the following account :

- 4.3 You may terminate your membership by giving ARES one-month notice in writing.
- 4.4 ARES may terminate your membership upon written notice: (a) should you breach any of the Terms herein; or (b) in the event ARES is, for whatever reason, unable to continue to use the premises for A*StartCentral.
- 4.5 You are responsible for maintaining good housekeeping for your Designated space.

5. Disclaimer, Limitation of Liability, Indemnity

- 5.1 Unless caused solely and directly by the negligence of the ARES, in no event shall ARES be liable to you or responsible for the death of or injury to you or any of your invitees, or any other persons howsoever caused.
- 5.2 ARES shall not be liable to you or responsible for any loss or damage to you, your invitee's, or any third parties' property, documents, chattel, equipment, goods or other items located at the Designated Space or within A*StartCentral's premises.
- 5.3 ARES shall not be liable for any special damages, consequential damages, indirect damages, loss of profit, contracts, business, revenues or savings arising howsoever incurred as a consequence of any delay, interruption or failure in the installations, equipment, or provisions of any services or facilities at the A*StartCentral.
- 5.4 ARES shall not be liable or responsible in any way for any loss, damage, injury or destruction whatsoever caused by fire, water, riot, act of God or other cause beyond ARES's control, any mechanical or other defect or breakdown, any shortage of manpower, fuel, electricity or water.

- 5.5 ARES shall not be liable or responsible in any way for the acts, omission, negligence or default of JTC, its employees, agents or contractors in connection with the Designated Space or the surrounding premises.
- 5.6 Subject to clause 5.1 above, you agree to fully indemnify ARES and its affiliates against any claim, demand, action, liability, loss, damage, cost, penalty or expense for any injury to any person or property at A*StartCentral, through any act or omission by you or your invitees arising out of or in connection with your use of the Designated Space and common equipment and facilities at A*StartCentral.
- 5.7 The limitations and exclusions of liability in this Clause 5 shall operate to the maximum extent permitted by applicable law.

6. General

- 6.1 The benefit of Membership is personal to you, and you understand that you may not assign or transfer any of the rights or obligations herein without ARES's consent.
- 6.2 Any delay or failure by either party to insist upon the performance of any one or more of the terms shall not be deemed to be a waiver of any rights and remedies that the parties may have and shall not be deemed a waiver of any subsequent breach or default. No provision herein shall be deemed to be waived by ARES unless such waiver is given in writing.
- 6.3 This Agreement may be amended only by the prior written agreement of the parties.
- 6.4 Any disputes arising under or in connection with this Agreement shall be referred by the Parties to arbitration by three arbitrators in accordance with the Arbitration Rules of the Singapore International Arbitration Centre (hereinafter referred to as the "**Rules**"). The Rules shall apply to such arbitral proceedings. The award of the arbitrators shall be final and binding upon the Parties and be enforceable in any court of competent jurisdiction.
- 6.5 This Agreement shall be governed in all respects by the substantive law of Singapore.
